MEMORABILITY

THE ROLE OF COLOR AND TYPOGRAPHY

- **ORANGE:** SUGGESTS CREATIVITY AND ENTHUSIASM, APPEALING TO INNOVATIVE CONSULTING APPROACHES.

CHOOSING THE RIGHT COLOR PALETTE CAN ENHANCE BRAND RECOGNITION AND ESTABLISH THE DESIRED EMOTIONAL CONNECTION WITH CLIENTS.

TYPOGRAPHY
