SUPPLIERS ARE ESSENTIAL BUSINESS ASSOCIATES THAT PROVIDE PRODUCTS OR SERVICES NECESSARY FOR A COMPANY'S OPERATIONS. THIS INCLUDES MANUFACTURERS, WHOLESALERS, AND SERVICE PROVIDERS. ESTABLISHING GOOD RELATIONSHIPS WITH SUPPLIERS CAN LEAD TO BETTER PRICING, RELIABILITY, AND QUALITY OF GOODS.
