- RENT OR LEASE PAYMENTS FOR OFFICE SPACE
- UTILITIES SUCH AS ELECTRICITY, WATER, AND INTERNET SERVICES
- OFFICE SUPPLIES AND EQUIPMENT

THESE EXPENSES ARE TYPICALLY STRAIGHTFORWARD TO DOCUMENT AND CLAIM, AS THEY ARE INCURRED REGULARLY IN THE COURSE OF BUSINESS OPERATIONS.

EMPLOYEE-RELATED EXPENSES

EXPENSES RELATED TO EMPLOYEES CAN ALSO BE DEDUCTED. THIS CATEGORY INCLUDES:

- SALARIES AND WAGES PAID TO EMPLOYEES
- EMPLOYEE BENEFITS, INCLUDING HEALTH INSURANCE AND RETIREMENT CONTRIBUTIONS
- Payroll Taxes

CLAIMING THESE DEDUCTIONS NOT ONLY REDUCES TAXABLE INCOME BUT ALSO INCENTIVIZES BUSINESSES TO INVEST IN THEIR WORKFORCE.

DEPRECIATION

DEPRECIATION ALLOWS BUSINESSES TO DEDUCT THE COST OF CERTAIN ASSETS OVER TIME. THIS INCLUDES ITEMS SUCH AS:

- BUILDINGS AND STRUCTURES
- Machinery and equipment
- VEHICLES USED FOR BUSINESS PURPOSES

Understanding how depreciation works can lead to significant tax savings for businesses investing in long-term assets.

ELIGIBILITY FOR DEDUCTIONS

Not all expenses are eligible for business deduction tax treatment. To qualify, an expense must be both ordinary and necessary for the business. An ordinary expense is common and accepted in the industry, while a necessary expense is helpful and appropriate for the business's operations.

How to Document Deductions

A: In some cases, yes. Certain deductions, such as net operating losses, can be carried forward to offset income in future tax years, subject to specific IRS rules.
