UNDERSTANDING HOW GRANTS WORK IS CRUCIAL FOR ANY BUSINESS OWNER LOOKING TO TAP INTO THESE FINANCIAL RESOURCES.

In Oregon, the availability of business grants reflects the state's commitment to fostering a supportive environment for small businesses and entrepreneurs. Various programs cater to different industries, ensuring that a wide range of business needs can be met through grant funding.

LOCAL GRANTS

OREGON BUSINESS DEVELOPMENT FUND

OREGON INNOVATION GRANT PROGRAM

THIS PROGRAM SUPPORTS INNOVATIVE PROJECTS WITH THE POTENTIAL FOR COMMERCIAL SUCCESS. IT AIMS TO FOSTER TECHNOLOGY ADVANCEMENT AND ENCOURAGE RESEARCH AND DEVELOPMENT EFFORTS IN OREGON'S BUSINESS LANDSCAPE.

RURAL BUSINESS DEVELOPMENT GRANTS

ADMINISTERED BY THE USDA, THESE GRANTS SUPPORT THE DEVELOPMENT OF SMALL AND EMERGING BUSINESSES IN RURAL AREAS. ELIGIBLE PROJECTS INCLUDE TECHNICAL ASSISTANCE, TRAINING, AND EQUIPMENT PURCHASES TO ENHANCE BUSINESS OPERATIONS.

OREGON ARTS COMMISSION GRANTS

FOR BUSINESSES IN THE ARTS SECTOR, THE OREGON ARTS COMMISSION PROVIDES GRANTS TO SUPPORT ARTISTIC PROJECTS AND INITIATIVES THAT BENEFIT THE COMMUNITY AND PROMOTE CULTURAL ENRICHMENT.

HOW TO APPLY FOR BUSINESS GRANTS

- TAX RETURNS

SEEK FEEDBACK
