TYPES OF BUSINESS LICENSES REQUIRED

UTILIZE ONLINE SEARCH TOOLS

MANY COUNTIES IN CALIFORNIA OFFER ONLINE SEARCH TOOLS THAT ALLOW YOU TO LOOK UP BUSINESS LICENSES BY ENTERING SPECIFIC CRITERIA SUCH AS THE BUSINESS NAME, OWNER NAME, OR LICENSE NUMBER. THESE TOOLS CAN PROVIDE VALUABLE INFORMATION ABOUT THE STATUS OF A BUSINESS LICENSE, INCLUDING WHETHER IT IS ACTIVE, EXPIRED, OR UNDER REVIEW.

CHECK FOR ADDITIONAL REQUIREMENTS
