#### UNDERSTANDING BUSINESS LICENSES IN TUSCALOOSA

A BUSINESS LICENSE NOT ONLY LEGITIMIZES A BUSINESS BUT ALSO PROVIDES CERTAIN PROTECTIONS AND BENEFITS, SUCH AS ACCESS TO GOVERNMENT CONTRACTS AND ELIGIBILITY FOR BUSINESS LOANS.

# Types of Business Licenses

# APPLICATION PROCESS FOR A BUSINESS LICENSE

IT IS ADVISABLE FOR BUSINESS OWNERS TO BUDGET FOR THESE COSTS AND CONSULT THE BUSINESS LICENSE OFFICE FOR AN ACCURATE FEE SCHEDULE.
