UNDERSTANDING BUSINESS LICENSES

A BUSINESS LICENSE IS A PERMIT ISSUED BY THE LOCAL GOVERNMENT THAT ALLOWS INDIVIDUALS OR COMPANIES TO CONDUCT BUSINESS WITHIN A SPECIFIED JURISDICTION. IN ALAMEDA COUNTY, HAVING A BUSINESS LICENSE IS NOT JUST A LEGAL REQUIREMENT; IT ALSO SIGNIFIES THAT THE BUSINESS ABIDES BY LOCAL REGULATIONS AND STANDARDS. THE PRIMARY PURPOSE OF A BUSINESS LICENSE IS TO ENSURE THAT BUSINESSES COMPLY WITH ZONING LAWS, HEALTH AND SAFETY REGULATIONS, AND OTHER MUNICIPAL CODES.

APPLICATION PROCESS FOR A BUSINESS LICENSE
