A: To be eligible for the business minor at the University of Washington, students must be enrolled in an undergraduate program and meet specific GPA requirements. Typically, students must complete prerequisite courses before declaring the minor.

A: Depending on your course load and scheduling, it is possible to complete the business minor in less than two years, especially if you take courses during summer sessions or manage a heavier course load during regular terms.
