- **FINANCIAL NEEDS:** PERSONAL FINANCIAL CIRCUMSTANCES MAY COMPEL A PARTNER TO EXIT THE BUSINESS AND LIQUIDATE THEIR INVESTMENT.
- **STRATEGIC CHANGES:** CHANGES IN BUSINESS STRATEGY OR FOCUS MAY REQUIRE ADJUSTMENTS IN PARTNERSHIP STRUCTURE.
