SATELLITE INTERNET IS AVAILABLE IN REMOTE AREAS WHERE OTHER OPTIONS MAY NOT BE FEASIBLE. HOWEVER, IT OFTEN COMES WITH HIGHER LATENCY AND LOWER SPEEDS, MAKING IT LESS SUITABLE FOR BUSINESSES THAT REQUIRE REAL-TIME DATA
