BUSINESSES SHOULD CONSIDER RECYCLING THE FOLLOWING MATERIALS:

- **PAPER:** THIS INCLUDES OFFICE PAPER, CARDBOARD, NEWSPAPERS, AND MAGAZINES. RECYCLING PAPER CONSERVES TREES AND REDUCES ENERGY CONSUMPTION.
- **PLASTICS:** MANY TYPES OF PLASTICS, INCLUDING BOTTLES, CONTAINERS, AND PACKAGING MATERIALS, CAN BE RECYCLED. IT'S IMPORTANT TO CHECK LOCAL GUIDELINES FOR SPECIFIC TYPES.
- **METALS:** ALUMINUM CANS AND STEEL PRODUCTS ARE HIGHLY RECYCLABLE AND CAN BE REUSED REPEATEDLY WITHOUT LOSS OF QUALITY.
- **GLASS:** GLASS BOTTLES AND JARS CAN BE RECYCLED INDEFINITELY. RECYCLING GLASS REDUCES ENERGY CONSUMPTION IN PRODUCTION PROCESSES.
- **ELECTRONICS:** E-WASTE RECYCLING IS BECOMING INCREASINGLY VITAL AS TECHNOLOGY ADVANCES. OLD COMPUTERS, PHONES, AND OTHER ELECTRONIC DEVICES SHOULD BE RECYCLED RESPONSIBLY.

## STEPS TO IMPLEMENT A BUSINESS RECYCLING PROGRAM

### 3. EDUCATE EMPLOYEES

TRAINING AND AWARENESS CAMPAIGNS ARE CRUCIAL FOR ENGAGING EMPLOYEES IN THE RECYCLING PROGRAM. PROVIDE INFORMATION ON WHAT CAN BE RECYCLED AND THE IMPORTANCE OF PARTICIPATION.

### 4. DESIGN AN EFFICIENT COLLECTION SYSTEM

## MEASURING SUCCESS

CONTAMINATION OCCURS WHEN NON-RECYCLABLE MATERIALS ARE MIXED WITH RECYCLABLES. TO MITIGATE THIS, CLEAR GUIDELINES SHOULD BE COMMUNICATED ABOUT WHAT MATERIALS ARE ACCEPTED FOR RECYCLING.

## INADEQUATE INFRASTRUCTURE

SOME BUSINESSES MAY LACK THE NECESSARY INFRASTRUCTURE FOR EFFECTIVE RECYCLING. INVESTING IN APPROPRIATE BINS AND SIGNAGE CAN IMPROVE THE RECYCLING PROCESS.

## CHANGING REGULATIONS

RECYCLING REGULATIONS CAN VARY BY REGION AND CHANGE OVER TIME. STAYING INFORMED ABOUT LOCAL LAWS AND WORKING WITH KNOWLEDGEABLE VENDORS CAN HELP ORGANIZATIONS REMAIN COMPLIANT.
