- **NEGOTIATION:** ENGAGING IN DISCUSSIONS WITH SUPPLIERS TO AGREE ON PRICING, TERMS, AND DELIVERY SCHEDULES.
- **PURCHASING:** THE ACTUAL ACQUISITION OF GOODS AND SERVICES BASED ON AGREED-UPON TERMS.
- **SUPPLIER MANAGEMENT:** OVERSEEING SUPPLIER PERFORMANCE AND MAINTAINING RELATIONSHIPS TO ENSURE CONTINUOUS IMPROVEMENT.

TYPES OF BUSINESS PROCUREMENT

BUSINESS PROCUREMENT CAN BE CLASSIFIED INTO VARIOUS TYPES BASED ON THE NATURE OF GOODS AND SERVICES BEING ACQUIRED. UNDERSTANDING THESE TYPES CAN HELP ORGANIZATIONS TAILOR THEIR PROCUREMENT STRATEGIES EFFECTIVELY. THE PRIMARY TYPES OF BUSINESS PROCUREMENT INCLUDE:

DIRECT PROCUREMENT

INDIRECT PROCUREMENT

THIS INCLUDES OFFICE SUPPLIES, MAINTENANCE SERVICES, AND IT SERVICES. ALTHOUGH OFTEN OVERLOOKED, INDIRECT PROCUREMENT CAN REPRESENT A SIGNIFICANT PORTION OF A COMPANY'S SPEND.

STRATEGIC PROCUREMENT

STRATEGIC PROCUREMENT FOCUSES ON LONG-TERM SUPPLIER RELATIONSHIPS AND THE STRATEGIC ALIGNMENT OF PROCUREMENT ACTIVITIES WITH ORGANIZATIONAL GOALS. THIS TYPE OF PROCUREMENT SEEKS TO CREATE VALUE THROUGH COLLABORATION AND INNOVATION, OFTEN INVOLVING PARTNERSHIPS WITH KEY SUPPLIERS.

OPERATIONAL PROCUREMENT

OPERATIONAL PROCUREMENT INVOLVES THE DAY-TO-DAY PURCHASING ACTIVITIES THAT ENSURE THAT AN ORGANIZATION HAS THE NECESSARY GOODS AND SERVICES TO FUNCTION. THIS INCLUDES ROUTINE PURCHASES AND REPLENISHMENT OF STOCK. OPERATIONAL PROCUREMENT IS ESSENTIAL FOR MAINTAINING SMOOTH BUSINESS OPERATIONS.

THE PROCUREMENT PROCESS

THIS EVALUATION PROCESS HELPS IDENTIFY AREAS FOR IMPROVEMENT AND STRENGTHENS SUPPLIER RELATIONSHIPS.
