LIMITED LIABILITY COMPANIES (LLCs)

TO DISSOLVE AN LLC IN TEXAS, THE OWNERS MUST FILE A CERTIFICATE OF TERMINATION WITH THE TEXAS SECRETARY OF STATE. THIS DOCUMENT OFFICIALLY ENDS THE EXISTENCE OF THE LLC AND MUST BE ACCOMPANIED BY ANY REQUIRED TAX FILINGS.

CORPORATIONS

FOR CORPORATIONS, THE BOARD OF DIRECTORS MUST ADOPT A RESOLUTION TO DISSOLVE, FOLLOWED BY A VOTE FROM THE SHAREHOLDERS. THE CORPORATION MUST THEN FILE THE ARTICLES OF DISSOLUTION WITH THE SECRETARY OF STATE, ALONG WITH A FINAL TAX RETURN TO REPORT ANY REMAINING ASSETS OR LIABILITIES.

TAX IMPLICATIONS OF CLOSING A BUSINESS
