- **EQUIPMENT FINANCING:** SPECIFICALLY DESIGNED FOR PURCHASING EQUIPMENT, THESE LOANS ALLOW BUSINESSES TO

ACQUIRE NECESSARY TOOLS WITHOUT DEPLETING THEIR CASH RESERVES.

- **SMALL BUSINESS ADMINISTRATION (SBA) LOANS:** THESE LOANS ARE PARTIALLY GUARANTEED BY THE GOVERNMENT, MAKING THEM LESS RISKY FOR LENDERS AND MORE ACCESSIBLE FOR SMALL BUSINESSES.

APPLICATION PROCESS FOR COMMERCIAL LOANS
