UNDERSTANDING THE COBB BUSINESS LICENSE

A COBB BUSINESS LICENSE, ALSO KNOWN AS A BUSINESS TAX CERTIFICATE, IS A PERMIT ISSUED BY THE COBB COUNTY GOVERNMENT THAT ALLOWS INDIVIDUALS AND COMPANIES TO LEGALLY CONDUCT BUSINESS WITHIN THE COUNTY. THIS LICENSE SERVES AS PROOF THAT A BUSINESS HAS MET ALL LOCAL REQUIREMENTS AND IS PERMITTED TO OPERATE. IT IS TYPICALLY REQUIRED FOR VARIOUS TYPES OF BUSINESSES, RANGING FROM RETAIL SHOPS TO SERVICE PROVIDERS.
