- **SOCIAL DEFINITION:** A BUSINESS SERVES A SOCIAL PURPOSE BY PROVIDING EMPLOYMENT, CONTRIBUTING TO COMMUNITY DEVELOPMENT, AND INFLUENCING SOCIETAL NORMS AND VALUES.

CORE COMPONENTS OF A BUSINESS

EVERY BUSINESS, REGARDLESS OF ITS TYPE OR SIZE, CONSISTS OF SEVERAL CRITICAL COMPONENTS THAT WORK TOGETHER TO ACHIEVE ITS GOALS. UNDERSTANDING THESE COMPONENTS IS ESSENTIAL FOR ANYONE LOOKING TO START OR MANAGE A

BUSINESS. THE MAIN COMPONENTS INCLUDE:

1. PRODUCT OR SERVICE

AT THE HEART OF ANY BUSINESS IS ITS PRODUCT OR SERVICE. THIS IS WHAT THE BUSINESS OFFERS TO ITS CUSTOMERS TO SATISFY THEIR NEEDS. A CLEAR UNDERSTANDING OF THE PRODUCT'S VALUE PROPOSITION IS CRUCIAL FOR SUCCESS.

2. MARKET

THE MARKET REFERS TO THE TARGET AUDIENCE OR CONSUMERS THAT THE BUSINESS AIMS TO SERVE. IDENTIFYING AND UNDERSTANDING THE MARKET IS ESSENTIAL FOR EFFECTIVE MARKETING AND SALES STRATEGIES.

3. REVENUE MODEL

A BUSINESS MUST HAVE A REVENUE MODEL THAT OUTLINES HOW IT WILL EARN MONEY. THIS CAN INCLUDE VARIOUS STRATEGIES LIKE SALES, SUBSCRIPTIONS, OR SERVICE FEES.

4. OPERATIONS

THE OPERATIONAL ASPECT INCLUDES THE PROCESSES AND RESOURCES REQUIRED TO DELIVER THE PRODUCT OR SERVICE. THIS MAY INVOLVE SUPPLY CHAIN MANAGEMENT, PRODUCTION PROCESSES, AND LOGISTICS.
