SPECIAL PERMITS AND LICENSES

SOME BUSINESSES MAY ALSO REQUIRE SPECIAL PERMITS OR LICENSES BASED ON THEIR SPECIFIC ACTIVITIES. THE APPLICATION PROCESS FOR BUSINESS LICENSES

A: BUSINESSES THAT ENGAGE IN ACTIVITIES LIKE FOOD SERVICE, ALCOHOL SALES, AND CERTAIN TRADES OFTEN REQUIRE SPECIAL PERMITS IN ADDITION TO A GENERAL BUSINESS LICENSE.

Q: CAN I APPLY FOR A BUSINESS LICENSE ONLINE?

A: YES, ESCAMBIA COUNTY OFFERS ONLINE APPLICATION OPTIONS FOR CERTAIN BUSINESS LICENSES, MAKING THE PROCESS MORE CONVENIENT FOR APPLICANTS.
