IT IS DESIGNED FOR EXPERIENCED PROFESSIONALS WHO SEEK TO ENHANCE THEIR MANAGEMENT AND LEADERSHIP SKILLS. DBA PROGRAMS OFTEN EMPHASIZE REAL-WORLD APPLICATIONS, STRATEGIC DECISION-MAKING, AND ADVANCED RESEARCH METHODOLOGIES.

PH.D. IN BUSINESS ADMINISTRATION

IN CONTRAST, A PH.D. IN BUSINESS ADMINISTRATION IS MORE RESEARCH-ORIENTED AND IS IDEAL FOR INDIVIDUALS LOOKING TO PURSUE ACADEMIC CAREERS, ENGAGE IN HIGH-LEVEL RESEARCH, OR TEACH AT THE UNIVERSITY LEVEL. THIS PROGRAM TYPICALLY INVOLVES RIGOROUS COURSEWORK FOLLOWED BY EXTENSIVE RESEARCH CULMINATING IN A DISSERTATION.

DOCTOR OF MANAGEMENT (DM)

THE DOCTOR OF MANAGEMENT FOCUSES ON THE APPLICATION OF MANAGEMENT THEORY AND PRACTICE IN ORGANIZATIONAL SETTINGS. THIS PROGRAM IS DESIGNED FOR SENIOR MANAGERS AND EXECUTIVES WHO WISH TO DEEPEN THEIR UNDERSTANDING OF MANAGEMENT PRACTICES, ORGANIZATIONAL BEHAVIOR, AND STRATEGIC DECISION-MAKING.

LETTERS OF RECOMMENDATION

APPLICANTS ARE OFTEN REQUIRED TO SUBMIT TWO OR THREE LETTERS OF RECOMMENDATION FROM PROFESSIONALS OR ACADEMICS WHO CAN ATTEST TO THEIR QUALIFICATIONS AND READINESS FOR DOCTORAL STUDY.

STATEMENT OF PURPOSE

A WELL-CRAFTED STATEMENT OF PURPOSE OUTLINING THE APPLICANT'S GOALS, RESEARCH INTERESTS, AND REASONS FOR CHOOSING THE SPECIFIC PROGRAM IS CRUCIAL FOR ADMISSION.

STANDARDIZED TEST SCORES

SOME PROGRAMS MAY REQUIRE STANDARDIZED TEST SCORES, SUCH AS THE GMAT OR GRE, ALTHOUGH MANY INSTITUTIONS ARE MOVING TOWARDS TEST-OPTIONAL POLICIES.

PROGRAM STRUCTURE AND CURRICULUM
