- DEPRECIATION OF ASSETS

VARIABLE EXPENSES

VARIABLE EXPENSES, ON THE OTHER HAND, FLUCTUATE BASED ON BUSINESS ACTIVITY. THESE COSTS CAN INCREASE OR DECREASE DEPENDING ON SALES VOLUME. EXAMPLES OF VARIABLE EXPENSES INCLUDE:

- COST OF GOODS SOLD (COGS)
- UTILITIES (WHICH MAY VARY WITH USAGE)
- MARKETING AND ADVERTISING COSTS
- COMMISSION-BASED PAY FOR SALES STAFF

OPERATING EXPENSES
