PORTFOLIO MANAGER

PORTFOLIO MANAGERS OVERSEE INVESTMENT PORTFOLIOS AND MAKE DECISIONS ON ASSET ALLOCATION. THEIR SALARIES CAN VARY WIDELY, BUT THEY TYPICALLY EARN BETWEEN \$100,000 AND \$250,000, WITH PERFORMANCE-BASED BONUSES THAT CAN SIGNIFICANTLY INCREASE THEIR EARNINGS.
