TYPES OF BUSINESSES

- **LARGE CORPORATIONS:** MULTINATIONAL CORPORATIONS WITH A SIGNIFICANT WORKFORCE AND GLOBAL REACH FALL INTO THIS CATEGORY.

BASED ON OWNERSHIP

BUSINESSES CAN ALSO BE CATEGORIZED BY THEIR OWNERSHIP STRUCTURE:

- **SOLE PROPRIETORSHIP:** A BUSINESS OWNED AND OPERATED BY A SINGLE INDIVIDUAL.
- **PARTNERSHIP:** A BUSINESS OWNED BY TWO OR MORE INDIVIDUALS WHO SHARE PROFITS AND RESPONSIBILITIES.
- **CORPORATION:** A LEGAL ENTITY SEPARATE FROM ITS OWNERS, PROVIDING LIMITED LIABILITY TO ITS SHAREHOLDERS.
- **COOPERATIVE:** A BUSINESS OWNED AND OPERATED BY A GROUP OF INDIVIDUALS FOR THEIR MUTUAL BENEFIT.

BUSINESS STRUCTURES

THE STRUCTURE OF A BUSINESS DETERMINES HOW IT OPERATES AND IS MANAGED. EACH STRUCTURE HAS ITS OWN LEGAL IMPLICATIONS, TAXATION, AND OPERATIONAL DYNAMICS.

COMMON BUSINESS STRUCTURES
