UNDERSTANDING GRANTS FOR IMMIGRANTS

GOVERNMENT GRANTS

GOVERNMENT GRANTS ARE AMONG THE MOST SIGNIFICANT SOURCES OF FUNDING FOR IMMIGRANT ENTREPRENEURS. THESE GRANTS MAY BE AVAILABLE THROUGH VARIOUS PROGRAMS AIMED AT STIMULATING ECONOMIC GROWTH AND SUPPORTING MINORITY-OWNED BUSINESSES. THEY OFTEN HAVE SPECIFIC ELIGIBILITY CRITERIA AND APPLICATION PROCESSES THAT MUST BE FOLLOWED CAREFULLY.

NONPROFIT ORGANIZATION GRANTS

IMMIGRANT ENTREPRENEURS SHOULD LOOK FOR LOCAL AND NATIONAL COMPETITIONS TO INCREASE THEIR CHANCES OF SUCCESS.

ELIGIBILITY CRITERIA FOR GRANT APPLICATIONS
