EVALUATING MARKET DEMAND

CONDUCTING MARKET RESEARCH

ORGANIZATION AND MANAGEMENT

THIS PART OUTLINES YOUR BUSINESS STRUCTURE AND INTRODUCES YOUR MANAGEMENT TEAM AND THEIR ROLES.

PRODUCTS AND SERVICES

DESCRIBE THE PRODUCTS OR SERVICES YOU PLAN TO OFFER, HIGHLIGHTING THEIR BENEFITS AND HOW THEY MEET CUSTOMER NEEDS.

MARKETING STRATEGY

DETAIL YOUR PLAN FOR ATTRACTING AND RETAINING CUSTOMERS, INCLUDING PRICING, PROMOTION, AND DISTRIBUTION STRATEGIES.

FINANCIAL PROJECTIONS

PROVIDE FORECASTS FOR REVENUE, EXPENSES, AND PROFITABILITY OVER THE NEXT FEW YEARS, INCLUDING BREAK-EVEN ANALYSIS.

CHOOSING A BUSINESS STRUCTURE

YOUR BUSINESS STRUCTURE AFFECTS YOUR TAXES, LIABILITY, AND OTHER LEGAL ASPECTS OF YOUR ENTERPRISE. COMMON BUSINESS STRUCTURES INCLUDE:
