WHILE THESE OPTIONS ARE MORE RELAXED, THEY SHOULD STILL BE USED JUDICIOUSLY AND ONLY WHEN YOU ARE CERTAIN THAT THE RECIPIENT WILL APPRECIATE THE INFORMALITY.

CRAFTING AN EFFECTIVE SUBJECT LINE

THE SUBJECT LINE IS A CRITICAL COMPONENT OF YOUR EMAIL, AS IT OFTEN DETERMINES WHETHER THE RECIPIENT OPENS YOUR MESSAGE. A COMPELLING SUBJECT LINE SHOULD BE CLEAR, CONCISE, AND RELEVANT TO THE CONTENT OF THE EMAIL.

A: A POLITE CLOSING AFTER THE OPENING COULD BE, "THANK YOU FOR YOUR ATTENTION TO THIS MATTER," OR "I LOOK FORWARD TO YOUR RESPONSE."
