IDENTIFYING THE RIGHT PARTNER

- **FINANCIAL STABILITY:** A PARTNER'S FINANCIAL SITUATION CAN IMPACT THE BUSINESS, SO CONSIDER THEIR ABILITY TO CONTRIBUTE RESOURCES AND HANDLE FINANCIAL OBLIGATIONS.
- **COMMUNICATION STYLE:** EFFECTIVE COMMUNICATION IS VITAL IN A PARTNERSHIP. CHOOSE A PARTNER WITH WHOM YOU CAN COMMUNICATE OPENLY AND CONSTRUCTIVELY.

CREATING A PARTNERSHIP AGREEMENT

LEGAL CONSIDERATIONS
