FIXED-PRICE CONTRACTS PROVIDE A SET PRICE FOR A SPECIFIC PROJECT. THESE CONTRACTS ARE ADVANTAGEOUS FOR THE GOVERNMENT AS THEY LIMIT COSTS, BUT THEY REQUIRE BUSINESSES TO MANAGE THEIR EXPENSES CAREFULLY.

COST-REIMBURSEMENT CONTRACTS

IN COST-REIMBURSEMENT CONTRACTS, THE GOVERNMENT AGREES TO PAY THE CONTRACTOR FOR ALLOWABLE COSTS INCURRED IN THE PERFORMANCE OF THE CONTRACT. THIS TYPE IS SUITABLE FOR PROJECTS WHERE COSTS ARE UNCERTAIN BUT CAN BE MORE COMPLICATED TO MANAGE DUE TO THE NEED FOR EXTENSIVE DOCUMENTATION.

TIME-AND-MATERIALS CONTRACTS

TIME-AND-MATERIALS CONTRACTS PAY CONTRACTORS BASED ON THE TIME SPENT AND MATERIALS USED. THESE ARE OFTEN USED IN SITUATIONS WHERE IT IS DIFFICULT TO ESTIMATE THE SCOPE OF WORK AHEAD OF TIME.

REGISTERING YOUR BUSINESS

BEFORE BIDDING ON GOVERNMENT CONTRACTS, BUSINESSES MUST COMPLETE SEVERAL REGISTRATION STEPS TO QUALIFY FOR GOVERNMENT CONTRACTING.

OBTAIN A D-U-N-S NUMBER

A D-U-N-S NUMBER, ISSUED BY DUN & BRADSTREET, IS A UNIQUE NINE-DIGIT IDENTIFIER FOR BUSINESSES. IT IS USED TO TRACK A COMPANY'S CREDITWORTHINESS AND IS REQUIRED FOR DOING BUSINESS WITH THE FEDERAL GOVERNMENT.

REGISTER IN SAM

THE SYSTEM FOR AWARD MANAGEMENT (SAM) IS THE PRIMARY DATABASE FOR GOVERNMENT CONTRACTORS. BUSINESSES MUST REGISTER IN SAM TO BE ELIGIBLE FOR FEDERAL CONTRACTS. THE REGISTRATION PROCESS INCLUDES PROVIDING DETAILS ABOUT THE BUSINESS, AS WELL AS FINANCIAL AND OWNERSHIP INFORMATION.

IDENTIFY NAICS CODES

THE NORTH AMERICAN INDUSTRY CLASSIFICATION SYSTEM (NAICS) CODES CLASSIFY BUSINESSES BY THEIR INDUSTRY. SELECTING THE APPROPRIATE NAICS CODES IS CRUCIAL AS IT HELPS THE GOVERNMENT IDENTIFY BUSINESSES ELIGIBLE FOR SPECIFIC CONTRACTS.

PREPARING YOUR BUSINESS FOR CONTRACTING

GETTING YOUR BUSINESS READY FOR GOVERNMENT CONTRACTING REQUIRES STRATEGIC PLANNING AND PREPARATION.

DEVELOP A BUSINESS PLAN

DEVELOP A BIDDING STRATEGY THAT CONSIDERS PRICING, DELIVERY SCHEDULES, AND RESOURCE ALLOCATION. BE COMPETITIVE WITHOUT UNDERBIDDING, AS THIS CAN COMPROMISE QUALITY AND SUSTAINABILITY.

COMPLIANCE AND MAINTENANCE

AFTER SECURING CONTRACTS, MAINTAINING COMPLIANCE AND MANAGING THE CONTRACT EFFECTIVELY IS ESSENTIAL.

UNDERSTAND COMPLIANCE REQUIREMENTS

EACH CONTRACT COMES WITH SPECIFIC COMPLIANCE REQUIREMENTS, INCLUDING REPORTING AND AUDITING. FAMILIARIZE YOURSELF WITH THESE TO AVOID PENALTIES AND MAINTAIN A GOOD STANDING WITH GOVERNMENT AGENCIES.

REGULARLY REVIEW PERFORMANCE
