- **CHOOSE A SUITABLE EXTENSION:** THE .COM EXTENSION IS THE MOST RECOGNIZED, BUT OTHER OPTIONS LIKE .NET, .BIZ, OR COUNTRY-SPECIFIC EXTENSIONS MAY ALSO BE APPROPRIATE.

REGISTERING YOUR DOMAIN NAME

ONCE YOU HAVE CHOSEN THE PERFECT DOMAIN NAME, REGISTER IT THROUGH A REPUTABLE DOMAIN REGISTRAR. POPULAR OPTIONS INCLUDE GoDaddy, Namecheap, and Google Domains. ENSURE THAT YOU MAINTAIN OWNERSHIP OF YOUR DOMAIN

BY REGULARLY RENEWING IT TO PREVENT LOSING IT.

SELECTING A HOSTING PROVIDER
