UNDERSTANDING BUSINESS LICENSES IN LEE COUNTY

DEFINITION AND IMPORTANCE

A BUSINESS LICENSE IS AN OFFICIAL PERMIT ISSUED BY A GOVERNMENT AGENCY THAT ALLOWS INDIVIDUALS OR COMPANIES TO CONDUCT BUSINESS WITHIN A SPECIFIC AREA.
