3. BUSINESS INFORMATION CENTERS

MANY LOCAL LIBRARIES AND COMMUNITY CENTERS OFFER BUSINESS INFORMATION SERVICES, INCLUDING ACCESS TO DATABASES, MARKET RESEARCH REPORTS, AND WORKSHOPS ON BUSINESS PLANNING.

LOCAL BUSINESS REGULATIONS IN LARA, MICHIGAN
