PARTNERSHIPS

CORPORATIONS

TYPES OF CORPORATIONS

THERE ARE DIFFERENT TYPES OF CORPORATIONS, INCLUDING:

- **C-CORPORATION:** THIS STANDARD CORPORATE STRUCTURE IS TAXED SEPARATELY FROM ITS OWNERS.

TAX IMPLICATIONS

CONSULT WITH A TAX PROFESSIONAL TO UNDERSTAND HOW DIFFERENT STRUCTURES WILL AFFECT YOUR TAX LIABILITIES.

COMMON MISTAKES TO AVOID

FOR EXAMPLE, SOLE PROPRIETORSHIPS AND PARTNERSHIPS TYPICALLY BENEFIT FROM PASS-THROUGH TAXATION, WHERE PROFITS ARE TAXED AT THE OWNERS' PERSONAL TAX RATES. IN CONTRAST, C-CORPORATIONS FACE DOUBLE TAXATION, WHILE S-CORPORATIONS AND LLCs CAN CHOOSE THEIR TAX TREATMENT.

Q: WHAT ARE THE LIABILITY IMPLICATIONS OF DIFFERENT BUSINESS STRUCTURES?

A: DIFFERENT BUSINESS STRUCTURES OFFER VARYING LEVELS OF LIABILITY PROTECTION. SOLE PROPRIETORSHIPS AND GENERAL PARTNERSHIPS EXPOSE OWNERS TO UNLIMITED PERSONAL LIABILITY, WHILE CORPORATIONS AND LLCs PROVIDE LIMITED LIABILITY PROTECTION, SHIELDING OWNERS' PERSONAL ASSETS FROM BUSINESS DEBTS AND LEGAL CLAIMS.

Q: CAN I CHANGE MY BUSINESS'S LEGAL STRUCTURE LATER ON?

A: YES, BUSINESSES CAN CHANGE THEIR LEGAL STRUCTURE AS THEY GROW AND THEIR NEEDS EVOLVE. HOWEVER, THIS PROCESS CAN INVOLVE LEGAL AND TAX IMPLICATIONS, SO IT IS ADVISABLE TO CONSULT WITH PROFESSIONALS BEFORE MAKING CHANGES.

Q: WHAT IS THE MOST COMMON LEGAL STRUCTURE FOR SMALL BUSINESSES?

A: THE MOST COMMON LEGAL STRUCTURE FOR SMALL BUSINESSES IS THE SOLE PROPRIETORSHIP DUE TO ITS SIMPLICITY AND EASE OF SETUP. HOWEVER, MANY SMALL BUSINESSES ALSO CHOOSE LLCs FOR THE LIMITED LIABILITY PROTECTION THEY PROVIDE.

Q: WHAT ARE THE COMPLIANCE REQUIREMENTS FOR CORPORATIONS?

A: CORPORATIONS FACE STRINGENT COMPLIANCE REQUIREMENTS, INCLUDING HOLDING ANNUAL MEETINGS, MAINTAINING CORPORATE MINUTES, FILING ANNUAL REPORTS, AND ADHERING TO STATE REGULATIONS REGARDING GOVERNANCE AND FINANCIAL REPORTING.

Q: WHY SHOULD I CONSIDER FORMING AN LLC INSTEAD OF A CORPORATION?

A: FORMING AN LLC CAN BE ADVANTAGEOUS DUE TO ITS FLEXIBILITY IN MANAGEMENT AND TAXATION, AS WELL AS PROVIDING LIMITED LIABILITY PROTECTION SIMILAR TO A CORPORATION. IT OFTEN INVOLVES FEWER FORMALITIES AND REGULATORY REQUIREMENTS THAN A CORPORATION.

Q: WHAT MISTAKES SHOULD I AVOID WHEN CHOOSING A BUSINESS STRUCTURE?
