UNDERSTANDING NAME AVAILABILITY AND TRADEMARK ISSUES

RESEARCHING TRADEMARKS

COMMON TRADEMARK CLASSIFICATIONS

TRADEMARKS ARE CLASSIFIED INTO DIFFERENT CATEGORIES BASED ON THE TYPE OF GOODS OR SERVICES OFFERED. UNDERSTANDING THESE CLASSIFICATIONS CAN HELP YOU IDENTIFY POTENTIAL CONFLICTS. COMMON CLASSIFICATIONS INCLUDE:

- CLASS 25: CLOTHING AND APPAREL
- CLASS 35: ADVERTISING AND BUSINESS SERVICES
- CLASS 41: EDUCATION AND ENTERTAINMENT SERVICES

REGISTERING YOUR BUSINESS NAME: STEPS AND REQUIREMENTS

ONCE YOU HAVE COMPLETED YOUR BUSINESS NAME SEARCH AND HAVE CONFIRMED THAT YOUR CHOSEN NAME IS AVAILABLE, THE NEXT STEP IS TO REGISTER YOUR BUSINESS NAME. HERE'S HOW TO DO IT.

STEP 2: FILE THE APPROPRIATE FORMS

Q: WHAT ARE FICTITIOUS BUSINESS NAMES (DBA)?

A: A FICTITIOUS BUSINESS NAME, ALSO KNOWN AS A "DOING BUSINESS AS" (DBA), IS A NAME THAT A BUSINESS USES THAT IS DIFFERENT FROM ITS LEGAL BUSINESS NAME. IT MUST BE REGISTERED WITH THE COUNTY IN WHICH THE BUSINESS OPERATES.

Q: ARE THERE ANY RESTRICTIONS ON CHOOSING A BUSINESS NAME IN CALIFORNIA?

A: YES, CALIFORNIA HAS RESTRICTIONS ON BUSINESS NAMES THAT MAY MISLEAD THE PUBLIC OR IMPLY ASSOCIATION WITH CERTAIN GOVERNMENT AGENCIES. ADDITIONALLY, CERTAIN WORDS MAY REQUIRE SPECIAL PERMITS OR LICENSES.

Q: HOW OFTEN SHOULD I CHECK THE AVAILABILITY OF MY BUSINESS NAME?

A: YOU SHOULD CHECK THE AVAILABILITY OF YOUR BUSINESS NAME AT MULTIPLE STAGES: BEFORE DECIDING ON A NAME, BEFORE REGISTERING, AND PERIODICALLY IF YOU PLAN TO EXPAND OR REBRAND IN THE FUTURE.

Q: WHAT HAPPENS IF I FAIL TO REGISTER MY BUSINESS NAME?

A: IF YOU FAIL TO REGISTER YOUR BUSINESS NAME, YOU MAY FACE LEGAL CHALLENGES FROM OTHER BUSINESSES USING THE SAME NAME OR RISK LOSING THE RIGHT TO USE THAT NAME ENTIRELY.
