**How do I make a change to my Local Business Tax Receipt?** Businesses moving from a city to the Unincorporated area of the County have to pay the Unincorporated tax, in addition to the transfer fee. The original Receipt, not a copy, needs to

**How do I apply for a City of Miami business tax receipt?** A Business Tax Receipt, formerly Occupational License, is required prior to engaging in or operating any business in the City of

Miami. A Cetificate of Use (CU) must first be obtained

**How do I view or request Local Business Tax Receipt information?** Customers may also use the County's Business Tracker to search for information on all businesses or professionals that opened or closed a Local Business Tax Account

**How do I renew the Local Business Tax Receipt? - Miami-Dade** Local Business Taxes are issued for one year beginning October 1 st and expire on September 30 th of each year. Renewal notices are mailed July 1 st of each year
