EQUITY FINANCING VS. DEBT FINANCING

ANOTHER ESSENTIAL DISTINCTION IN BUSINESS FINANCE IS BETWEEN EQUITY FINANCING AND DEBT FINANCING. EQUITY FINANCING INVOLVES RAISING CAPITAL BY SELLING SHARES OF THE COMPANY, WHEREAS DEBT FINANCING INVOLVES BORROWING MONEY THAT MUST BE REPAYED WITH INTEREST. BUSINESSES OFTEN USE A COMBINATION OF BOTH TO OPTIMIZE THEIR CAPITAL STRUCTURE.
