THE SHOW'S POPULARITY HAS NOT ONLY ENTERTAINED MILLIONS BUT HAS ALSO SERVED AS A PLATFORM FOR MANY ENTREPRENEURS TO LAUNCH OR ELEVATE THEIR BUSINESSES.

- **EFFECTIVE PITCH:** THE ABILITY TO COMMUNICATE THE BUSINESS IDEA CLEARLY, PASSIONATELY, AND SUCCINCTLY CAN SIGNIFICANTLY INFLUENCE INVESTORS' DECISIONS.
- **SCALABILITY:** INVESTORS FAVOR BUSINESSES THAT HAVE THE POTENTIAL TO GROW AND EXPAND INTO NEW MARKETS.
- **SOLID FINANCIALS:** DEMONSTRATING SOUND FINANCIAL HEALTH AND A CLEAR PATH TO PROFITABILITY IS CRUCIAL FOR ATTRACTING INVESTMENT.

FOUNDED IN 2013 BY DAVID HEATH AND RANDY GOLDBERG, BOMBAS IS A SOCK COMPANY THAT FOCUSES ON COMFORT AND PERFORMANCE. THE COMPANY GAINED IMMENSE POPULARITY AFTER RECEIVING A \$200,000 INVESTMENT FROM DAYMOND JOHN. BOMBAS HAS SINCE GENERATED OVER \$100 MILLION IN SALES AND IS KNOWN FOR ITS COMMITMENT TO SOCIAL RESPONSIBILITY, DONATING A PAIR OF SOCKS FOR EVERY PAIR SOLD.

2. SQUATTY POTTY

SQUATTY POTTY, A TOILET STOOL DESIGNED TO PROMOTE HEALTHIER BOWEL MOVEMENTS, BECAME A HOUSEHOLD NAME AFTER ITS APPEARANCE ON SHARK TANK. THE FOUNDERS, BOBBY AND JUDY EDWARDS, SECURED A \$350,000 INVESTMENT FROM LORI GREINER. SINCE THEN, THE COMPANY HAS GENERATED OVER \$30 MILLION IN SALES, LEVERAGING VIRAL MARKETING AND HUMOR IN ITS ADVERTISING CAMPAIGNS.

3. RING

RING, A SMART DOORBELL COMPANY FOUNDED BY JAMIE SIMINOFF, REVOLUTIONIZED HOME SECURITY. SIMINOFF PITCHED HIS PRODUCT ON SHARK TANK BUT DID NOT SECURE AN INVESTMENT. HOWEVER, RING WENT ON TO ACHIEVE MASSIVE SUCCESS, EVENTUALLY SELLING TO AMAZON FOR OVER \$1 BILLION. THE PRODUCT'S ABILITY TO CONNECT HOMEOWNERS WITH THEIR FRONT DOOR VIA SMARTPHONE TECHNOLOGY HAS BEEN A GAME-CHANGER IN SMART HOME SECURITY.

4. SIMPLY FIT BOARD

SIMPLY FIT BOARD, A BALANCE BOARD DESIGNED FOR FITNESS, WAS PITCHED BY ENTREPRENEURS LINDA CLARK AND GLORIA HOFFMAN. THE DUO RECEIVED AN INVESTMENT OF \$125,000 FROM LORI GREINER, AND THE PRODUCT BECAME A FITNESS SENSATION, GENERATING OVER \$160 MILLION IN SALES. THE BOARD'S SIMPLICITY AND EFFECTIVENESS HAVE APPEALED TO A WIDE AUDIENCE, MAKING IT A MUST-HAVE FITNESS ACCESSORY.

5. THE BOUQS COMPANY

THE BOUQS COMPANY, AN ONLINE FLOWER DELIVERY SERVICE, FOCUSES ON FRESH, ECO-FRIENDLY FLOWERS SOURCED FROM SUSTAINABLE FARMS. FOUNDER JOHN TABIS RECEIVED A \$1 MILLION INVESTMENT FROM ROBERT HERJAVEC AND HAS SINCE EXPANDED THE BUSINESS SIGNIFICANTLY. THE BOUQS COMPANY HAS CHANGED THE WAY CONSUMERS THINK ABOUT FLORAL ARRANGEMENTS, EMPHASIZING SUSTAINABILITY AND QUALITY.
