STRUCTURE OF NAICS CODES

NAICS codes consist of SIX DIGITS. EACH DIGIT REPRESENTS A SPECIFIC LEVEL OF DETAIL REGARDING THE INDUSTRY CLASSIFICATION:

- THE FIRST TWO DIGITS DESIGNATE THE SECTOR.
- THE THIRD DIGIT SPECIFIES THE SUBSECTOR.
