MISCONCEPTION: OWNERSHIP EQUALS CONTROL

LASTLY, IT IS OFTEN BELIEVED THAT OWNERSHIP EQUATES TO COMPLETE CONTROL. HOWEVER, OWNERS MUST CONSIDER STAKEHOLDERS, EMPLOYEES, AND MARKET CONDITIONS, WHICH CAN INFLUENCE THEIR DECISION-MAKING.
