CONTACT THE APPROPRIATE AUTHORITIES

ONCE YOU HAVE COLLECTED SUFFICIENT EVIDENCE, THE NEXT STEP IS TO REPORT THE UNLICENSED BUSINESS TO THE APPROPRIATE AUTHORITIES. THIS MAY INCLUDE:

- YOUR LOCAL OR STATE LICENSING BOARD.
- THE BETTER BUSINESS BUREAU (BBB).
- CONSUMER PROTECTION AGENCIES.
- LOCAL LAW ENFORCEMENT IF ILLEGAL ACTIVITIES ARE SUSPECTED.

FILE A FORMAL COMPLAINT

MANY REGULATORY AGENCIES HAVE FORMAL COMPLAINT PROCESSES THAT CAN BE COMPLETED ONLINE OR IN PERSON. ENSURE YOU PROVIDE ALL NECESSARY INFORMATION AND DOCUMENTATION TO SUPPORT YOUR CLAIM.

WHAT HAPPENS AFTER REPORTING
