UNDERSTANDING SALT LAKE COUNTY BUSINESS LICENSE

A SALT LAKE COUNTY BUSINESS LICENSE IS A LEGAL AUTHORIZATION THAT ALLOWS INDIVIDUALS OR ENTITIES TO OPERATE A BUSINESS WITHIN THE COUNTY'S JURISDICTION.
