THEY TYPICALLY INVEST THEIR PERSONAL FUNDS AND MAY ALSO OFFER MENTORSHIP AND ADVICE TO ENTREPRENEURS. ANGEL INVESTORS ARE OFTEN FOUND IN LOCAL NETWORKS AND ARE INVOLVED IN VARIOUS INDUSTRIES.

VENTURE CAPITALISTS

VENTURE CAPITALISTS (VCS) ARE PROFESSIONAL INVESTORS WHO MANAGE POOLED FUNDS FROM VARIOUS SOURCES TO INVEST IN HIGH-GROWTH STARTUPS. THEY OFTEN SEEK BUSINESSES WITH INNOVATIVE PRODUCTS OR SERVICES THAT CAN SCALE RAPIDLY. VCS USUALLY REQUIRE A SIGNIFICANT EQUITY STAKE AND EXPECT A SUBSTANTIAL RETURN ON INVESTMENT WITHIN A DEFINED TIMEFRAME.

FAMILY AND FRIENDS

MANY ENTREPRENEURS TURN TO FAMILY AND FRIENDS FOR INITIAL FUNDING. THIS INFORMAL APPROACH CAN BE LESS INTIMIDATING AND MORE ACCESSIBLE BUT CARRIES THE RISK OF STRAINING PERSONAL RELATIONSHIPS IF THE BUSINESS DOES NOT SUCCEED. CLEAR AGREEMENTS AND PROFESSIONAL EXPECTATIONS SHOULD BE ESTABLISHED WHEN SEEKING INVESTMENT FROM CLOSE CONTACTS.

PRIVATE EQUITY FIRMS

PRIVATE EQUITY FIRMS INVEST IN ESTABLISHED COMPANIES, OFTEN TAKING A CONTROLLING INTEREST. THESE FIRMS TYPICALLY FOCUS ON IMPROVING OPERATIONAL EFFICIENCY AND PROFITABILITY BEFORE SELLING THE BUSINESS OR TAKING IT PUBLIC. WHILE THIS OPTION MAY NOT BE SUITABLE FOR ALL SMALL BUSINESSES, IT CAN PROVIDE SIGNIFICANT CAPITAL AND STRATEGIC OVERSIGHT.

BENEFITS OF SMALL BUSINESS PRIVATE INVESTORS
