ACCORDING TO THE U.S. SMALL BUSINESS ADMINISTRATION, SMALL BUSINESSES ACCOUNT FOR APPROXIMATELY 99.3% OF ALL BUSINESSES IN SOUTH CAROLINA. THIS STATISTIC HIGHLIGHTS THE VITAL ROLE THAT THESE ENTERPRISES PLAY IN ECONOMIC STABILITY AND GROWTH.
