- **CORPORATION:** A MORE COMPLEX STRUCTURE THAT PROVIDES LIABILITY PROTECTION BUT REQUIRES MORE REGULATORY COMPLIANCE. IT CAN BE A C CORPORATION OR AN S CORPORATION, AFFECTING TAXATION AND OWNERSHIP.

REGISTERING YOUR BUSINESS
