IT IS OFTEN REFERRED TO AS THE "BUSINESS PARTNER NUMBER" (BPN) AND IS SPECIFICALLY USED FOR ENTITIES THAT ARE REGISTERED FOR SALES TAX, CORPORATE INCOME TAX, AND OTHER TAX-RELATED PURPOSES.

WHO NEEDS A FLORIDA BUSINESS PARTNER NUMBER?

ANY BUSINESS ENTITY THAT ENGAGES IN COMMERCE WITHIN FLORIDA, INCLUDING BUT NOT LIMITED TO CORPORATIONS, LLCs, AND PARTNERSHIPS, MAY NEED A FLORIDA BUSINESS PARTNER NUMBER. THIS IS PARTICULARLY RELEVANT FOR BUSINESSES THAT:

- SELL GOODS OR SERVICES SUBJECT TO SALES TAX
- EMPLOY EMPLOYEES AND NEED TO REPORT PAYROLL TAXES
- FILE CORPORATE INCOME TAX RETURNS
- ENGAGE IN REGULATED INDUSTRIES REQUIRING ADDITIONAL COMPLIANCE

AFTER SUBMITTING YOUR APPLICATION, YOU WILL RECEIVE YOUR FLORIDA BUSINESS PARTNER NUMBER. THIS NUMBER SHOULD BE KEPT IN A SECURE LOCATION, AS IT WILL BE NEEDED FOR VARIOUS BUSINESS TRANSACTIONS AND COMPLIANCE ACTIVITIES.

USES OF THE FLORIDA BUSINESS PARTNER NUMBER

A: IF YOUR BUSINESS IS INACTIVE BUT STILL REGISTERED, IT IS ADVISABLE TO MAINTAIN YOUR FLORIDA BUSINESS PARTNER NUMBER. HOWEVER, IF YOUR BUSINESS IS COMPLETELY DISSOLVED, YOU MAY NOT NEED IT.

Q: HOW DO I UPDATE MY INFORMATION ASSOCIATED WITH MY FLORIDA BUSINESS PARTNER NUMBER?

A: TO UPDATE YOUR INFORMATION, YOU MUST CONTACT THE FLORIDA DEPARTMENT OF REVENUE AND PROVIDE THE NECESSARY DOCUMENTATION TO REFLECT THE CHANGES IN YOUR BUSINESS DETAILS.
