DEFINING THE ANTIDERIVATIVE

AN ANTIDERIVATIVE OF A FUNCTION $f(x)$ IS A FUNCTION $F(x)$ SUCH THAT $F'(x) = f(x)$. THE FIRST PART OF THE THEOREM STATES THAT IF F IS AN ANTIDERIVATIVE OF f , THEN:

$$F(b) - F(a) = \int_a^b f(x) dx$$

THIS EQUATION EXPRESSES THAT THE DEFINITE INTEGRAL OF f OVER THE INTERVAL $[a, b]$ CAN BE COMPUTED USING THE VALUES OF ITS ANTIDERIVATIVE AT THE ENDPOINTS. THIS RELATIONSHIP IS CRUCIAL FOR EVALUATING INTEGRALS WITHOUT DIRECTLY CALCULATING LIMITS OF RIEMANN SUMS.

PROOF OF THE FIRST PART

4. CONCLUDE: SINCE $F'(x) = f(x)$, F IS INDEED AN ANTIDERIVATIVE OF f . THEREFORE, WE CAN WRITE:
5. $F(b) - F(a) = f(c)(b - a)$ FOR SOME c IN $[a, b]$ ACCORDING TO THE MEAN VALUE THEOREM, CONFIRMING THE THEOREM'S ASSERTION.
