Morton Abramowitz of the Carnegie Endowment for Peace once said that Soros was “the only

private citizen with his own foreign policy.” Anna Porter has interviewed Soros, his senior staff, journalists, politicians, and many others in an attempt to understand the man. Each person has a unique story to tell. Focusing on the last decade, she explores how Soros’s Open Society Foundations have spread his ideas of human rights, democracy, Western liberalism, and participatory capitalism around the globe. These are the ideas Soros has said he considers worth dying for. How have they translated into reality? What will his legacy be?
