FURTHERMORE, IT CONTRIBUTES TO ENHANCING OVERALL SECURITY POSTURE BY PREPARING INDIVIDUALS TO ANTICIPATE, DETECT, AND RESPOND TO TERRORIST ACTIVITIES WITH GREATER CONFIDENCE.

PURPOSE IN SECURITY AND DEFENSE CONTEXTS

IN MILITARY, GOVERNMENT, AND CORPORATE SECURITY CONTEXTS, THE ANTITERRORISM TRAINING PRETEST PLAYS AN ESSENTIAL ROLE IN REINFORCING THE IMPORTANCE OF VIGILANCE AND PREPAREDNESS. KEY COMPONENTS OF THE ANTITERRORISM TRAINING PRETEST
