BACKGROUND AND EARLY LIFE OF ANTOINETTE FRANK

PERSONAL AND SOCIAL BACKGROUND

DETAILS REGARDING FRANK'S PERSONAL LIFE, INCLUDING HER FAMILY BACKGROUND AND SOCIAL ENVIRONMENT, CONTRIBUTE TO A FULLER UNDERSTANDING OF THE CIRCUMSTANCES LEADING UP TO THE CRIMES.
