COMMON MISUNDERSTANDINGS AND CLARIFICATIONS

DESPITE ITS CLEAR DEFINITION, SOME MISUNDERSTANDINGS ABOUT THE PHRASE "CASE IN POINT" OCCUR, PARTICULARLY REGARDING ITS PROPER USAGE AND MEANING. THESE MISCONCEPTIONS SOMETIMES APPEAR IN REDDIT THREADS, PROMPTING CLARIFICATIONS FROM OTHER USERS.

FREQUENT MISINTERPRETATIONS

CLARIFYING PROPER USAGE

BENEFITS IN DISCUSSION AND DEBATE

USING "CASE IN POINT" ALLOWS SPEAKERS AND WRITERS TO:
