A 2014 study with a limited sample size (N=16) found that just over 55% of graduates had either become CFP professionals or were in the process of that journey. Conversely, the remaining 45% were not pursing the designation at all. This paper begins to investigate why graduates may choose non-CFP paths after parting ways with their Alma mater. Discoveries on this topic will undoubtedly help registered programs better reach testing goals while also preparing graduates for careers in financial planning.
