LEGAL REQUIREMENTS AND COMPLIANCE

COMPLIANCE WITH 18 U.S.C. § 2257 REGULATIONS IS MANDATORY FOR THE ADULT ENTERTAINMENT INDUSTRY. For each of these reproductive variables, the range of data gleaned from the literature is given, together with the source of each value listed. Virginia Hayssen is Assistant Professor of Biology at Smith College. Ari Van Tienhoven is Professor of Animal Physiology, Emeritus, at Cornell University. Ans Van Tienhoven assisted in the compilation of data for the book.
