THE FACTUAL CIRCUMSTANCES REQUIRED THE COURT TO CONSIDER WHETHER AN INTENTIONAL ACT WAS COMMITTED DESPITE THE ABSENCE OF A DESIRE TO CAUSE HARM.

## LEGAL ISSUES PRESENTED

## IMPLICATIONS FOR INTENT IN TORT LAW
